4. Alternate two insulation system for T201. (GSE/ GSE-130C; GENERAL COMPONENTS INDUSTRY CORP/ GCI-B)
5. Alternate one EMI filter source. (Yunpen Electronic Co Ltd/ YO15T1)
6. Alternate one fan. (ADDA CORP/ AD3812VB-B5BDS)
